

ORDINANCE NUMBER 1019

AN ORDINANCE OF THE BOARD OF COMMISSIONERS OF THE CITY OF BURKBURNETT, TEXAS, CANVASSING THE ELECTION RETURNS AND DECLARING ELECTION RESULTS IN THE GENERAL ELECTION HELD IN THE CITY OF BURKBURNETT ON MAY 7, 2022 TO ELECT THE MAYOR, COMMISSIONER FOR PLACE 3, AND COMMISSIONER FOR PLACE 4.

On this the 16th day of May 2022, The Board of Commissioners of the City of Burk Burnett, Texas convened in a Special-Called meeting open to the public at the regular meeting place thereof with the following members present, to wit:
