

## **ORDINANCE NUMBER 1072**

**AN ORDINANCE OF THE BOARD OF COMMISSIONERS OF THE CITY OF BURKBURNETT, TEXAS AMENDING THE BURKBURNETT CODE OF ORDINANCES: CHAPTER 97: PARKS AND RECREATION: AMENDING SECTIONS 15-26 RIVER CREEK PARK: SECTION 37 CONTRACTS; RESERVATION FEES: SECTION 51 DEPOSIT RULES; PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.**

**WHEREAS**, the Board of Commissioners finds that it is in the best interest of the City to amend Chapter 97: Parks and Recreation of the Code of Ordinances.

**NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF BURKBURNETT, TEXAS, THAT:**

### **Part 1: River Creek Park**

Chapter 97 Sections 15 through 26 River Creek Park be removed from the Code of Ordinances as it is no longer used as a park.

### **Part 2. Contracts; Reservations; Fee**

(F) Reservations may be made for dances and music concerts. The reservation fee for dances shall include a fee of \$50.00 per hour for a uniformed police officer for an event with at least 100 participants, \$120.00 per hour for two uniformed police officers for 101-299 participants, etc. Any group permitting alcoholic beverages or having 50 or more minors involved shall pay for at least one police officer. Police officers will be provided by the Chief of Police. This shall apply to dances, music concerts, and any event where alcoholic beverages are permitted.

### **Part 3. Deposit Rules**

(A) A deposit fee of \$200.00 or \$400.00 if serving alcohol is required for the reservation.

(C) Any reservation not confirmed by the \$200.00 and/or \$400.00 deposit within one week will automatically be canceled.

### **Part 4. Severability**

In the event any portion of this ordinance is held to be invalid, illegal or unenforceable, such invalidity, illegality, or unenforceability shall not affect the validity, legality, or enforceability of the other provisions of this ordinance.

### **Part 5. Effective Date**

This ordinance shall be in full force and effect after passage.

**Part 6. Open Meetings**

It is hereby officially found and determined that the meeting at which this Ordinance is passed was open to the public as required by law and that public notice of the time, place, and purpose of said meeting was given as required by law.
